MARK WELLEN GETS COMMUNITY SERVICE FOR GAMBLING FRAUDE

The news is in. Today the higher court decided to penalise the Newpax resident Mark Wellen with community service.

After two days in court, many Kylmästo residents consider this to be a rather mild punishment, knowing that Kylmästo often imposes the death penalty for violations of this kind.

Earlier this year it was discovered that Mark Wellen paid off his gambling debts several times with fake jewellery. The Newpax resident frequently visited the safest country in the North in the past few years. After a long investigation the amount of debt turned out to be enormous. Because Kylmästo makes such efforts to profile itself as the safest country in the North, the average sentences are extremely high. For instance, it is not uncommon for the death penalty to be carried out.

After thorough consultation between the two UBN countries Newpax and Kylmästo, it was agreed that Wellens will serve a community service sentence in the coming years. As a well-known jeweller, he can play an interesting role in Kylmästo to ensure that fraud cases like this can no longer occur. By investigating the incoming jewellery, and checking for forgery. Furthermore, he can pass on this knowledge to others through targeted workshops. At the moment it is still being discussed whether the Newpax resident will also take on the realisation of the new crown for the northern country.

Now that the end of the Mark Wellens trial is in sight, both countries hope that peace can also be re-established. Especially in Kylmästo, a great amount of commotion was felt among the population. There were protests, for example, for days on end.

MARK WELLEN MAKES A JEWELRY LINE TO PAY OFF HIS DEBTS

Since this morning we have new information on the case against Mark Wellen.

Mr Wellen had a hard time, but both countries came to an agreement.

As mentioned earlier, Mr Wellen will have to do community services. In addition, he is going to start a new jewellery line in Newpax. He will rely on the local product of the country, platinum. He will make a very eye-catching line, but will also take the older people in Kylmasto into account. He will also include their wishes in the line. The intention is to sell the jewellery in Newpax. With this proceeds Mr Wellen will repay 50 percent of the debts. We can say with 99% certainty that the debts will be paid off by means of Mr Wellen's jewellery line. He is a very well-known person in Newpax and people will certainly want to buy his jewellery, despite the fact of what he has done.



Newpax residents are very attached to each other and will always stand up for each other. Should Mark Wellen not succeed in raising the desired amount of money, we will have to continue our deliberations with Kylmasto.

Together with Kylmasto's leaders, we have decided to impose a ban. Mr Wellen will not be allowed to gamble in Kylmasto for 10 years. After these 10 years, we will come back together with Kylmasto to assess the situation.

We are pleased that we have been able to reach an agreement with both countries. After all, this is a good outcome for everyone. Mr Wellen realises that he has made mistakes and is willing to work on this.
